Optional safety equipment recommended include knee pads, athletic cup (boys) or sports bra (girls), kidney belt, and a hockey helmet with face guard.
- **Helmet policy:** Use of helmets are optional in Battle Game Sports and Hobbies, LLC activities. Occasionally players do receive strikes to the head by mock weapons.
